

Community Guidelines – getyourdate

Status: May 2026

Our platform connects people to experience shared activities and build new connections.

To ensure that “getyourdate” remains safe, respectful, and enjoyable for everyone, the following binding Community Guidelines apply.

By using the platform, you agree to comply with these rules.

1. Minimum Age

Use of “getyourdate” is strictly limited to persons aged 18 years or older.

Minors are prohibited from using the platform.

2. Respectful Conduct

Always treat other users respectfully and fairly.

The following are strictly prohibited:

- insults,
- discrimination,
- hate speech,
- racist or extremist content,
- sexual harassment,
- aggressive, threatening, or intimidating behavior,
- stalking or unwanted pursuit,
- bullying or deliberate provocation.

Boundary-crossing behavior will not be tolerated.

3. Honest and Authentic Profiles

Your profile must represent you truthfully and authentically.

The following are prohibited in particular:

- fake profiles,
- identity deception,
- catfishing,

- misleading information,
 - use of third-party images or data without permission,
 - multiple accounts intended to circumvent suspensions or bans.

4. Permitted Content

You may only upload or publish content for which you hold the necessary rights.

Content must not:

- violate applicable laws,
 - infringe third-party rights,
 - infringe trademark, copyright, or personality rights,
 - contain harmful files or malware.

5. Prohibited Content

The following content is strictly prohibited:

- pornographic or sexually explicit content,
 - glorification of violence,
 - threats of violence,
 - extremist content,
 - hate speech,
 - discriminatory content,
 - illegal content of any kind,
 - self-harm related content,
 - drug, weapon, or illegal sales offers,
 - escort, prostitution, or similar services,
 - spam,
 - scams or fraudulent activities,
 - fake giveaways,
 - commercial advertising or unauthorized solicitation.

6. Safety During Meetings

Meetings between users take place entirely at the users' own responsibility.

We expressly recommend:

- initially meeting in public places,
- handling personal information cautiously,
- exercising particular caution with unknown persons,
- informing friends or family about meetings,
- immediately leaving uncomfortable situations.

“getyourdate” assumes no responsibility for meetings taking place outside the platform.

7. Handling of Personal Data

The sharing of personal data takes place at your own responsibility.

Be especially cautious when sharing:

- telephone numbers,
- residential addresses,
- banking information,
- social media profiles,
- other sensitive information.

The publication or sharing of third-party personal data without consent is prohibited.

8. No Commercial Use

The platform is intended exclusively for private social activities.

The following are prohibited in particular:

- advertising,
 - spam,
 - commercial offers,
 - affiliate marketing,
 - business solicitation,
 - multi-level marketing,
 - sales offers,
 - unauthorized promotion.

9. No Automated Use

The use of automated systems is prohibited.

This includes in particular:

- bots,
 - automated scraping,
 - automated bulk messaging,
 - technical manipulation attempts,
 - circumvention of security mechanisms.

10. Reporting and Blocking

Users may report content or behavior that violates these rules or applicable law.

Users may also block other users.

We reserve the right to review reported content or accounts and to take appropriate action.

11. Consequences of Violations

In the event of violations of these Community Guidelines, our Terms and Conditions, or applicable law, we reserve the right in particular to:

- remove content,
- restrict functions,
- issue warnings,
- temporarily suspend user accounts,
- permanently delete user accounts.

In cases of serious or criminal violations, we additionally reserve the right to:

- preserve content,
 - disclose data to authorities within the legally permissible framework,
 - initiate legal action.

12. Protection of the Platform and Community

We reserve the right to take measures necessary to ensure:

- the security of the platform,
- the protection of users,
- the technical integrity of the platform,

- compliance with legal requirements,
 - and a respectful community environment.
